STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:

ABSORB LIQUID IN VERMICULITE, FLOOR ABSORBENT OR OTHER ABSORBENT MATERIAL. SWEEP UP AND PLACE IN A PROPER WASTE DISPOSAL CONTAINER.

WASTE DISPOSAL METHOD:
